

# KingsWellies Nursery – Daycare of Children Nursery Service Duty of Candour Report – 31 January 2020 to 31 January 2021

#### Introduction

All health and social care services in Scotland have a duty of candour. This is a legal requirement which means that when things go wrong and mistakes happen, the people affected understand what has happened, receive an apology and the organisation learns how to improve for the future. An important part of this duty is that we provide an annual report about the duty of candour during the time between 31 January 2020 and 31 January 2021. We hope you find this report useful.

## 1. About KingsWellies Nursery

KingsWellies Nursery is a Private Nursery located in Prime Four Business Park in Kingswells, Aberdeen. We provide daycare from 7.30am to 6pm, Monday to Friday for 50 weeks of the year. We are closed 2 weeks over the Christmas Period. We care for children aged 3 months to 5 years old. We work in partnership with the local authority (Aberdeen City Council) which means that for every 3-5 year old child, we can provide 1140 funded hours of Early Learning and Childcare.

## 2. How many incidents happened to which the duty of candour applies?

In the last year, there have been no incidents to which the duty of candour applies. These are where types of incidents have happened which are unintended or unexpected, and do not relate directly to the natural course of someone's illness or underlying condition.

### 3. To what extent did KingsWellies Nursery follow the duty of candour procedure?

There have been no incidents. Had any of the events listed above happened, we would have followed the correct procedure. This means we would have informed the parents affected, apologised to them, and offered to meet with them. We would have fully reviewed what happened and what went wrong to try and learn for the future.



#### 4. Covid 19

In December 2020, we experienced a number of positive cases of Covid 19. Staff and children were affected. No one was hospitalised. All cases connected to the nursery, experienced either no symptoms or very mild symptoms. All policies and procedures were followed accurately and immediately. The nursery was also closed from 14<sup>th</sup> December 2020 until 18<sup>th</sup> December 2020 in order to minimise the spread of infection. Aberdeen City Council, Health Protection Team Scotland, The Care Inspectorate, parents, staff and all stakeholders were also informed and continuously updated.

## 5. Information about our policies and procedures

Where something has happened that triggers the duty of candour, our staff report this immediately to the nursery manager who has responsibility for ensuring that the duty of candour procedure is followed. The manager records the incident and reports as necessary to the Care Inspectorate. When an incident has happened, the manager and staff will set up a learning review. This allows everyone involved to review what happened and identify changes for the future. All new staff learn about the duty of candour at their induction. We know that serious mistakes can be distressing for staff as well as the people who use our care and their families. We have support in place for our staff if they have been affected by a duty of candour incident. Where parents or children are affected by the duty of candour, we have arrangements in place to provide welfare support as necessary.

## 6. What has changed as a result?

Not applicable. There have been no incidents.
